
Greetings to everyone gathered in Boston for the 67th Council and General Conference of the International Federation of Library Associations and Institutions.

Keynote Address At Opening Session




"Ordinary Resurrections: Literacy, Hope and Education in the Third World and the U.S.A"

"Boston: A Virtual Trip Around the World"


An exhibition of rare books from countries around the world. The exhibit is located in the Rare Books and Manuscripts Department, third floor, McKim Building.



The campaign is based on ALA's @ your library™, The Campaign for America's Libraries, a five-year public awareness campaign launched during National Library Week last April with the help of First Lady Laura Bush, a librarian and teacher.

The campaign for the World's libraries will use a trademarked brand, @ your library™, and its official translations, to unify the communications activities of libraries around the world. "The IFLA conference is the perfect venue for unveiling this campaign," Berry said. "With the conference theme 'Libraries & Librarians Making a Difference in the Knowledge Age,' we have a wonderful

opportunity to speak loudly and clearly about the value of libraries and librarians in the 21st century all around the world." "Our message is that libraries are changing and dynamic places provide information, education entertainment, no matter where they are," said Ross Shimmon, IFLA's Secretary General. "Libraries are places of opportunity that bridge the world. the smallest connect even Thev communities in the smallest of countries to our larger international community."

Through outreach efforts, the campaign will target the general public, educators, government leaders and policymakers, librarians and those who are considering the library profession, the media and strategic partners, including funding agencies.
