Previous award recipients include Shidhulai Swanirvar Sangstha of Bangladesh; China Evergreen Rural Library Service Center; Aarhus Public Libraries in Denmark; Smart Cape Access Project of Cape Town, South Africa; BibloRed library network of Bogotá, Colombia; Proyecto Bibliotecas Guatemala (Probigua); Biblioteca del Congreso de la Nación of Argentina; and Helsinki City Library of Finland.

## IFLA STRATEGIC PLAN 2006-2009

Below are the draft Strategic Directions and Strategic Actions that would guide IFLA until 2009. The Governing Board intends to have its final discussion on this Plan at its meeting on Saturday, August 26<sup>th</sup>. Please provide any comments to the Strategic Planning Committee, in writing, by Friday, August 25<sup>th</sup> to the IFLA Offices, Room 317. A full implementation plan will be developed by the Governing Board for discussion at its December meeting.

## STRATEGIC DIRECTIONS

### **Profession Pillar**

IFLA will assist libraries and information services to fulfil their purposes and shape responses to the needs of clients in a rapidly changing information environment.

1. IFLA will take the lead in collaborative efforts to establish **guidelines and standards** for the organization of information for access across international boundaries and over social, cultural, and economic barriers.

# Strategic Actions

- a. Enable users to find, identify, select, and obtain information through international agreed standards and guidelines (eg: metadata, resource control, document supply, etc.)
- b. Develop guidelines and best practices through Sections and Divisions to provide guidance to I libraries and promote cooperation
- c. Support an integrated approach to the management of digital resources
- d. Promote resource sharing to assist library users to access and receive needed resources from beyond their own library
- e. Promote cooperation, resource sharing, and seamless access among libraries, museums, and archives
- f. Develop and disseminate guidelines for teaching various aspects of library work, both in the academic courses and in lifelong professional programs.
- 2. IFLA will promote the development of **quality library and information service** in all parts of the world.

- Develop and deliver programs and activities of IFLA Sections and discussion groups
- b. Work with colleagues and local library stakeholders in developing countries to assist in capacity building for the library profession, library institutions, and library and information services through the Action for Development through Libraries Programme (ADLP)
- c. Support IFLA sections and discussion groups in the development and delivery of quality programs and activities.





3. IFLA is a source of **professional publications** to assist libraries and information services in improving their governance, management, and services.

## Strategic Actions

- a. Revitalization of IFLANET for professional development and exchange.
- b. Produce print and electronic publications on topics of high interest to the profession and in the widest possible range of languages (IFLA Journal, the green series, section publications)
- 4. IFLA will work to **strengthen library associations**, especially in developing countries.

## Strategic Actions

- a. Develop and roll out the GLAD (Global Library Association Development) Programme.
- Develop and deliver workshops and other training events to train and equip office-bearers of national library associations for the democratic, effective and efficient governance of their associations
- c. Develop a set of guidelines for associations on how to identify potential membership markets, increase and sustain members (especially young professionals).
- 5. IFLA will assist libraries and information services to avoid and recover from destruction resulting from natural disasters, neglect, and conflict.

## Strategic Actions

- a. Publish guidelines for disaster prevention and recovery
- b. Promote the protection of cultural heritage especially in times of conflict (international committee of the blue shield, ICBS)
- c. Facilitate provision of advice or assistance following disasters.

# **Society Pillar**

IFLA, working with libraries and information services, will assist people throughout the world to create and participate in an equitable information/knowledge society and to exercise their rights of freedom of access to information and freedom of expression in their daily lives.

6. IFLA will develop and conduct an effective **advocacy programme** in support of libraries, librarians, and library users worldwide.

- a. Create an advocacy capability at IFLA headquarters and develop an advocacy campaign focusing on the following themes:
  - Freedom of access to information and freedom of expression and its implementation through library and information services
  - Equity in the area of copyright; information flow among rich and poor nations; and intellectual property
  - Inclusion in the areas of information access in an information society and building information/knowledge societies





- b. To strengthen IFLA's advocacy capacity through consolidation and the building of partnerships
- c. Promote implementation of the recommendations from the World Summit on the Information Society (WSIS)
- d. Implement Libraries on the Agenda campaign
- e. Promote reading, information literacy and life long learning as keys to participation in the information society.
- f. Support the basic right to health through worldwide access to professional and consumer health literacy training.
- 7. IFLA will materially **affect international policies and practices** in key areas relating to libraries and information services.

## Strategic Actions

- a. Influence international copyright law and intellectual property law so that library users have access to information under principles of fair use (CLM)
- b. Promote the need to respect the rights to information and freedom of expression (FAIFE)
- c. Advance the protection of and access to information and cultural resources throughout the world (FAIFE, ALP, PAC, Blue Shield, World Digital Library)

# **Members Pillar**

IFLA will be well managed and will provide services to members through efficient communication, exemplary programs, and learning opportunities that increase their ability to provide quality service to their clientele

8. IFLA will **communicate** with divisions, sections, and discussion groups as well as with current and potential members **systematically** and effectively

- Implement assertive management of the services for members and the corporate partners and recruitment of new members including electronic renewals
- b. Establish an electronic newsletter directed to officers and members
- c. Improve communication with and services to Section officers including orientation of new officers and a discussion list for officers
- d. initiate a systematic and continuous process of monitoring the needs and wishes of our membership, starting in 2007 by undertaking a membership survey, and following this up by continuous monitoring in subsequent years
- e. following the initial survey, develop an integrated communication strategy and plan that reaches out to IFLA'S "indirect" members (the members of LA members and the staff of institutional members)
- f. Develop a toolkit for IFLA divisions, sections, and discussion groups that helps to identify potential membership markets, retain current members, and recruit new members.

9. IFLA will provide **forums** and other opportunities **for networking** to assist the professional development of current and potential members.

## Strategic Actions

- Organize an annual World Library and Information Congress that is efficiently managed, financially beneficial to IFLA, SUSTAINABLE, and reasonably priced for members
- Deliver exemplary continuing education programs and other events that allow attendees to gain knowledge about their field and about international librarianship
- c. Promote other IFLA-branded conferences and meetings that allow members to present and exchange information and expertise
- d. Increase the involvement of members in IFLA
- 10. IFLA manages the organisation effectively and manages IFLA headquarters and other offices efficiently to meet the needs of current and potential members.

## Strategic Actions

- a. Increase capacity of all IFLA offices to support the Strategic Directions and Actions.
- b. Thoroughly renovate IFLA's information technology systems to improve administrative efficiency and for more effective communication, including the integration of database systems and the redesign of the IFLA website as the central communication and administrative tool.
- 11. IFLA **receives financial support** through increased membership and fund raising to support current and increased services to members.

## **Strategic Actions**

- a. Allocate and manage IFLA's finances effectively and efficiently to enable achievement of IFLA's goals
- b. Recruit new members both from underrepresented countries and in countries with a tradition of IFLA membership
- c. Recruit additional corporate partners
- d. Develop diverse, broad based and stable sources of funding
- 12. IFLA will **examine its structure** (including statutes revision, core activities, and the number of sections)

- a. Review sections, taking a life-cycle approach to professional groups, streamlining IFLA, and making it more responsive
- b. Review and revise IFLA statutes
- c. Review core activities to move toward greater diversity and flexibility





# Global Statistics for the 21st Century

It is more than 30 years since UNESCO developed, with help from IFLA, the statistics that it collects to provide data on libraries.

Since then, the world has changed, and one of the challenges for the library community is to provide better evidence about use of libraries and information resources, in the context of the actions arising from the World Summit on the Information Society.

The IFLA Statistics and Evaluation Section has been working with the UNESCO Institute for Statistics, and with ISO, to develop better measures which will allow both developed and developing countries to provide better data on the use of libraries and information resources.

Details of the proposal have been published in the Section's Newsletter for July 2006 (available from the IFLA website).

Our first task is the help UNESCO to identify the best sources for gathering data, using IFLA's extensive contacts throughout the library world. We shall be talking to colleagues (especially those in Division VIII) during the conference, and shall be seeking your help between now and December to compile a database of institutions of every kind which compile or hold collections of library data in each country.
