Report of the Standing Committee of Classification and Indexing meetings, Oslo, 2005 / Rapport des séances du comité permanent, Classification et Indexation, Oslo, 2005

This report is a summary of the minutes of the two meetings of the Standing Committee that were held on Saturday, August 13 and Friday August 19 at the Oslo conference. The meeting Minutes can be consulted on the Section's IFLA page. (http://www.ifla.org/VII/s29/minutes/s29_minutes2005.pdf)

The meetings were chaired by Marcia Zeng, the Chair of the Standing Committee and the minutes were taken by Barbara Tillett, the secretary. The first point of business was the election of the new Section Chair and Secretary for 2005-2007. Patrice Landry was elected the new chair and Barbara Tillett was elected ongoing Secretary/ Treasurer. The new chair then appointed Maria Witt as Information Coordinator and Billie Hackney and Jo-Anne Bélair as Newsletter editors.

Reports were given on the section developments since the Buenos Aires Conference. The section's working groups reported on progress made over the last year. Marcia Zeng reported on behalf of Gerhard Riesthuis that the "final draft" of the Guidelines for Multilingual Thesauri was posted on IFLANET for review, and many positive comments and suggestions had been received. During the Oslo conference, the WG reviewed Gerhard Riesthuis's latest version, and Ia McIlwaine will prepare the final version with Gerhard Riesthuis during the Fall 2005. It is planned that the Guidelines will be posted on IFLANET and would probably be issued as an IFLA Professional Report in 2006.

David Miller reported on the Working Group on Virtual Clearinghouse of Subject Access Tools and proposed some modifications to the action plan of the WG. He proposed that the group focus its attention on gathering information on tools used by national libraries and information centres. The aim is now to create a series of linked pages on IFLANET organised by geographical area / nation / language and topic. The WG will make a serious effort to contact a wide range of Library and Information Science professionals from around the world with special attention to establishing contact with librarians from regions with which we have very little contact.

Patrice Landry reported on the revised WG Guidelines of Subject Access by National Bibliographic Agencies. With the retirement of Martin Kunz, the group was reformed with a new mandate. During the conference, the WG decided to collect NBA indexing policies in order to determine if a survey is needed in order to provide sufficient information to compile general guidelines. The WG is planning to issue its Guidelines in 2007. The group will work in collaboration with the Bibliography Section WG on Guidelines for Electronic National Bibliographies. The section is also involved in the work of two other WG's. Marcia Zeng reported that the section is leading the Bibliographic Control Division's working group on Functional Requirements for Subjects Authority Records (FRSAR). The WG will be composed of core members as well as an "advisory group" composed of other interested parties.

Also, the Working Group on a Multilingual Dictionary of Cataloguing Terms and Concepts (MulDiCat) led by the Cataloguing Section working group will resume its work this coming year. Jo-Anne Bélair and Leda Bultrini will represent the section on this WG dedicated to building a multilingual thesaurus of cataloguing and subject indexing terms. Their task will be to contribute subject indexing and controlled vocabulary terminology terms.

The Section's Newsletter was discussed. Patrice Landry proposed that the content of the November issue be revised in order to focus more on the work of the Standing Committee and the work of its members. The new editors of the newsletter, Jo-Anne Bélair and Billie Hackney, will also gather information on recent IFLA activities. In particular they will report on the recent IFLA conference, and reports from the working groups. The May issue will continue the practice of presenting recent developments in the field of classification and indexing in many countries, the so-called "countries reports."

The planning of future conference programmes proceeded with the organisation of both the Seoul and Durban conferences. The programme of the Seoul section's programme will be entitled "Interoperability for subject access for multilingual/multiscript networked environment, especially in Asia." A call for papers will be sent out in October.

The Durban conference programme was discussed and the working theme for that conference is "Partners for subject access to bring libraries and users together." This topic will be further discussed at the next section meetings in Seoul.

The programmes at the Oslo conference were discussed and it was agreed that the three papers from the round table discussion of principles and strategies be proposed to ICBC for publication. An introduction and conclusion should also be submitted. The paper by Unni Knutsen given at the Division of Bibliographic Control would be proposed for publication in the IFLA Journal.

Classification and Indexing Section Annual Report 2004-2005

Scope Statement

The Classification and Indexing Section focuses on methods of providing subject access in catalogues, bibliographies, and indexes to documents of all kinds, including electronic documents. It serves as a forum for producers and users of classification and subject indexing tools. It works to facilitate international exchange of information about methods of providing subject access; to promote standardization and uniform application of classification and subject indexing tools; to initiate and promote advice on research in the subject approach to information; and to disseminate research results through open meetings and publications.

Programmes at recent IFLA conferences included papers on subject access resources and

applications in Europe and South America. Future programmes will include attention to activities in Europe, Asia, and Africa. A Working Group has developed Guidelines for the Construction of Multilingual Thesauri and released it for a world-wide review. Other Working Groups are continuing their work in establishing a Virtual Clearinghouse for Subject Access Resources that are used world wide and the Guidelines for Subject Access by National Bibliographic Agencies. The Section also participates in other activities of the Division of Bibliographic Control, such as FRBR model to subject authority records, which led to a new Working Group of Functional Requirements for Subject Authority Records (FRSAR). The section continues to co-operate with the Cataloguing, Bibliography, and Information Technology Sections and UNIMARC and to participate in other IFLA activities related to bibliographic control.

Membership

The section has 115 institution and individual members from 44 countries (as of October 2004).

Standing Committee and officers

The Standing Committee had 20 members from 14 countries during 2004-2005. The following nations are represented: Canada, Czech, Estonia, Finland, France, Germany, Iceland, Italy, Macedonia, Portugal, Russia, Sweden, Switzerland, and the United States. There were also five corresponding members. Marcia Lei Zeng and Barbara Tillett were the Chair and Secretary for 2003-2005. The Information Coordinator and Newsletter editor was Patrice Landry. Eight committee members finished their terms at the Oslo Conference and nine new members joined the Committee. They are from France, USA, Germany, Malaysia, Estonia, Norway, Portugal, and Sweden. The new committee elected Patrice Landry and Barbara Tillett to serve as the Chair and Secretary for 2005-2007. Maria Witt became new Information Coordinator of the Section. Billie Hackney and Jo-Anne Bélair are section newsletter editors.

Oslo conference, August 2005

A programme jointly organized with the Cataloguing Section, entitled "**Cataloguing and Subject Tools for Global Access: International Partnerships**," was presented at the 2005 Oslo Conference. The program attracted about 200 people. Simultaneous translations were provided for all IFLA languages. The Classification and Indexing Section's part focused on subject tools such as classifications and subject headings. This year, our speakers were from Czech Republic, Switzerland, Germany, Canada, and France. Their presentations covered many more than the countries they came from. The experiences of collaborative projects involving Slovakia, Slovenia, Croatia, Macedonia, Lithuania, Latvia, Austria, Germany, Switzerland, Canada, and France brought us the most exciting approaches to global subject access.

The papers and presenters were:

1) Maria Balikova: Multilingual Subject Access to Catalogues of National Libraries (MSAC): Czech Republic's collaborations with Slovakia, Slovenia, Croatia, Macedonia, Lithuania and Latvia;

2) Patrice Landry and Magda Heiner-Freiling: The use of the Dewey Decimal Classification for the organisation of national bibliographies: the German language approach proposed by Austria, Germany and Switzerland; and

3) Jo-Anne Bélair and Françoise Bourdon: The Répertoire de vedettes-matière and RAMEAU: two indexing languages in French: a necessary luxury.

After the presentations, a panel discussion was monitored by Gunilla Jonsson, Chair of Cataloguing Section, on the principles and strategies from different aspects, such as access and sharing of subject and name authority data as well as authority work in the archival context. Marcia Zeng talked about Sharing and Use of Subject Authority Data at the panel.

The Section participated in the Division IV open program, "**Bibliographic Control: current issues and initiatives.**" Marcia Zeng reported recent activities of the Classification and Indexing section and Division's new FRSAR Working Group activities.

The Section had its Standing Committee meeting in two sessions during the Oslo conference. The

meeting was attended by 20 members and many observers (11 and 9). Continuing and new working groups reported their activities. Plans for the 2006 and 2007 programs were discussed. The Strategic Plan for 2005-2007 was revised. Working groups had their meetings separately. Committee members also participated in the Division IV Social Hour activity where they met committee members from other sections in Division IV. The officers participated in the Division's officers meeting, held in two sessions, during the conference.

Projects and working groups

1. Guidelines for the construction of multilingual thesauri

The Working Group met in Oslo after the meetings in Buenos Aires (2004), Berlin (2003), Glasgow (2002), and Amsterdam (2002). A decision was made to publish the Guidelines for the Construction of Multilingual Thesauri by early 2006. A final draft version of the Guidelines was posted on IFLANET for a worldwide review and received great feedback within two months. The Working Group has been chaired by Gerhard Riesthuis. Professor Ia McIlwaine are working on the final English version based on the comments received.

2. A Virtual Clearing-House of Available Subject Access Resources

The Working Group was established during the Berlin Conference to create a virtual clearinghouse of available subject access tools. The WG, chaired by David Miller, had met online frequently and in person during the conferences. Members of the WG have prepared sample annotations of about 20 subject access tools. For the coming year, the WG plans to focus on identifying subject access resources, which are either used by national libraries or used on the national level. Examples of the latter would be in national union catalogues, or national bibliographies not maintained by a national library. In a second tier, the effort will be to include other important resources. Subgroups to deal with specific issues or regions of the world were formed at the Oslo Conference.

3. Guidelines for Subject Access by National Bibliographic Agencies

This Working Group was established at the Berlin Conference in 2003 and re-launched at 2005 Oslo Conference. This WG is chaired by Patrice Landry. The tasks are identified as to: collect and study the indexing policies and practice of the national bibliographic agencies, analyze data, and draft guidelines. It is expected that the WG will issue the Guidelines in 2007.

4. Division Working Group on Functional Requirements for Subject Authority Records (FRSAR)

The Classification and Indexing Section is taking the lead role for the new Division-level Working Group FRSAR. Marcia Zeng, Maja Zumer, and Athena Salaba are in charge of the WG which has eight members. An Advisory Group of six members was also formed in 2005. The terms of the references of this WG are: to build a conceptual model of Group 3 entities within the FRBR framework as they relate to the aboutness of works; to provide a clearly defined, structured frame of reference for relating the data that are recorded in subject authority records to the needs of the users of those records; and to assist in an assessment of the potential for international sharing and use of subject authority data both within the library sector and beyond. The chairs met several times before and during the FRBR Dublin Workshop "FRBR in 21st Century Catalogues: An Invitational Workshop" in May 2005 and presented at the Workshop. The WG and AG met at Oslo Conference and decided to start examining the definitions related to Group 3 entities and investigating how real users use subject authority data. Two subgroups were formed.

5. Cross-Section Working Group on MulDiCat

This is a Working Group on Multilingual Dictionary of Cataloguing Terms and Concepts, established by the Cataloguing Section in 2002. Jo-Anne Bélair and Leda Bultrini will coordinate the involvement of Classification & Indexing members and volunteers.

Section newsletter

The section continues to publish a Newsletter for Section members, members of the Standing Committee and others interested in classification and indexing. Two issues have been published during the current year. This acts as a channel for imparting information about what is happening at the national level and for sharing the experiences of others. Countries that have reported activities of classification and subject indexing resources during recent years include Canada, Czech, Estonia, France, Germany, Iceland, Italy, Macedonia, Norway, Romania, Russia, Sweden, Switzerland, United Kingdom, and the United States. The newsletter is also an excellent forum for the discussion of matters of international concern relating to classification and indexing. Contributions are always very welcome.

Future conferences

Seoul, 2006

A programme for the 2006 IFLA Conference was discussed at 2004 and 2005 conferences. At the Oslo conference, the following theme for the Seoul Conference was chosen: Interoperability for subject access for multilingual/multiscript networked environment, especially in Asia. Possible speakers and topics from Asian countries were considered. A call for paper was sent out in November 2005.

Durban, 2007

A programme for the 2007 IFLA Conference was also discussed during the committee meetings. A theme was proposed for building partnerships for subject access to bring libraries and users together.

Relationships with Other Bodies

The Section continues to cooperate with other IFLA Sections and Divisions and with the Permanent UNIMARC Committee in various projects and activities. Barbara Tillett, secretary of the Classification and Indexing Section and chair of Division IV, serves as the chair of the planning committee for the series of cataloguing experts on an International Cataloguing Code (IME ICCs). She is also the liaison to the UBCIM Working Group on FRANAR. Barbara Tillett also continues to participate in the FRBR review group.

Papers should be in one of the IFLA languages with a version in English to allow for translation. 20 minutes will be allowed for a summary delivery of the paper in the Classification and Indexing Section's programme.

Françoise Bourdon has occupied various positions at the Bibliothèque nationale de France since 1976, the most recent ones being managing the name authority file of the BN-OPALE catalogue, the services within the Direction du développement scientifique et des réseaux (DDSR) [= Direction of scientific development and networks], the Standards Office of the BnF. Since 2003 she has been head of the Service for bibliographic cooperation, in charge of the National Center for RAMEAU (French subject headings), the French ISSN Center, the BnF Standards Office, the definition and coordination of the bibliographic products proposed by the BnF, the liaison with the clients of the products, and the part of the BnF website devoted to information for professionals in the field of information and documentation. member), and since 2005 is a member of the Standing Committee of Classification and Indexing Section. In 1990-1991 she was awarded a Robert Vosper Fellowship for an international study on authority files. She also works within the French Organization for standardization (AFNOR) and holds several teaching positions in various units for library and documentation specialists. She has published numerous articles, translations and several books on authority control.

Billie Hackney is Head of Monograph Cataloging at the Getty Research Institute Research Library. She has been working in the cataloging field since 1990. Joining the Standing Committee will allow her to expand her knowledge of international classification and indexing issues.

Yvonne Jahns has been employed since 1993 as a subject librarian at Die Deutsche Bibliothek - the national library and national bibliographic information centre for Germany. She works at the Department of Classification & Indexing in Leipzig in the field of law and economics.
