

National Libraries Section Annual report September 2015 – August 2016

Our Annual Report records our achievements and progress in relation to our Action Plan 2015-2017. The action plan submitted in 2015 was over ambitious for the section. Future plans will be more realistic. At the second SC meeting in Columbus it was agreed that the Section should continue the survey, and that it was better to focus on one main activity than to try to be over ambitious in planning. The SC agreed to keep using e-mail and the web pages for information, plus Basecamp where appropriate. Communication via Facebook, twitter, blogs, etc. was not retained.

Objectives identified in action plan and their realization

 Serve as a forum to share and learn from the experience of the practical problems of national libraries, in order to promote benchmarking, best practices and quality models, and to improve management skills. Promote research in fields of interest to national libraries, always considering the opportunities to share experiences with other groups within IFLA and in close cooperation with CDNL, and to promote the contribution of national libraries to the profession

The nat-lib list has not been active this year. With the completion of the survey, it is hoped that a discussion can be started. The Chair and Secretary of the section met the Chair and vice-Chair of CDNL in December 2015 to discuss areas of cooperation. CDNL agreed to promote and distribute the survey indicated under point 2 below. See also point 10 below.

2. Prepare an inventory of National Library tasks to assist colleagues across the world in defining their own activities and to lobby governments

This has been very successful. In 2015 work has started on an Inventory of best practices for national libraries. An initial national library functions case study was carried out in spring 2015 and has formed the basis of a questionnaire developed and shared in 2016. 3. Encourage national libraries to promote inclusive access to their collections for all through digitisation, access policies, promotion through social media

Lack of resources meant the section did not address this point.

4. The Section will work with IFLA to engage with partners in cultural heritage to develop and promote standards and good practice guidelines and encourage national libraries to be strong advocates for collecting, preserving and providing open access to every nation's documentary heritage

The section secretary has worked with PAC on the preparation of the IFLA survey on best practices in preservation.

5. The Section will promote the IFLA Risk Register encouraging national libraries (and others) to document library collections at risk during times of crisis, conflict or disaster

Lack of resources meant the section did not address this point.

6. The Section will support IFLA in its work with UNESCO on digital preservation including the PERSIST project which provides a roadmap for digital sustainability.

No formal contact has occurred.
