6a. IFLA International Newspapers **Conference, Mozhaisk, 13-16 April 2009** Theme of the Conference: *Legal deposit of newspapers for libraries: challenges of the digital environment.* The conference had been successful, with some 40-50 delegates attending. The papers of the conference are to be published in English and in Russian, as part of the IFLA Saur series, later in 2009. Konstantin Sukhorukov was thanked for writing accounts of the conference in two Russian journals, and the links to these will be circulated. 6b. IFLA Satellite meeting, 19-20 August 2009. The Conference venue is the Royal Library, Stockholm. The theme of the Conference is to be: "The Present becomes the past: harvesting, archiving, presenting today's digitally produced newspapers" The conference had been successful, with some 80-90 delegates attending, which met the planning target. The Chairman asked for the thanks of the Section to be given again to colleagues from the National Library of Sweden.

6c. World Library and Information Congress: 75th IFLA General Conference and Council. "Libraries create futures: building on cultural heritage" 23-27 August 2009, Milan, Italy.

- **6d. 32nd Business meeting and Conference 2010**. This is to be held at the Indira Ghandi National Centre for the Arts (IGNCA), New Delhi, 18-21 January 2010. [Secretary's note: IGNCA have proposed now a date in March/ April 2010 for this conference.] The Theme of the conference is to be Digital Preservation and Access to News and views. The 32nd Business Meeting of the Section will be held prior to this conference. Suggestions for the conference programme include:
- securing sponsors
- looking at criteria for acceptance of papers
- Visit premises of a company digitising newspapers
- Visit the Library of Congress Field Office
- secure a speaker from the Indian newspaper publishers; to describe the state of newspaper publishing in India
- examine the state of legal deposit for newspapers in India
- consider the matter of securing a speaker from the Philippines
- Alexander Dhzigo and Konstantin Sukhorukov and Majlis Bremer-Laamanen would be nominated to the International Advisory Committee
- Invitations would be sent to colleagues in Malaysia, Australia, China, Punjab
- A website to be established for this conference. Action: Frederick Zarndt

It was agreed that a draft programme (to be of 3 or 4 days) is to be put together as soon as possible, ideally by mid- September. Invitations will be sent to countries, inviting their participation.

6e. IFLA World Library and Information Congress: 76th IFLA General Conference and Council. Gothenburg, Sweden, 10-15 August 2010.

The suggested theme for this conference open session to be: Relations between publishers, standards organisations, and libraries. Transforming links between publishers, readers and libraries as repositories.

7. Election of Officers

- **7.1** Chairman and Secretary. A motion to co-opt Frederick Zarndt to the Standing Committee was proposed by Hartmut Walravens and seconded by Ed King. This motion was carried unanimously by Standing Committee. It was agreed that Frederick Zarndt be elected as Chairman and Pär Nilsson be elected as Secretary of the IFLA Newspapers Section. The role of Information Co-Ordinator was confirmed at the SCII held on the 25 August it was agreed that Christoph Albers be the Section Information Co-Ordinator.
- **7.2** Membership. Ed King reported that, at July 2009, there were 33 institutional members, and 3 personal members.
- **7.3** Financial report. Ed King reported that the 325 EURO allocated for the section would be drawn from IFLA HQ for the expenses relating to the Section Newsletter no. 19, and for the publication of the conference papers of 2009.
- **7.4** Section Newsletter. Number 20 will be produced under the direction of the new officers.

7.5 Directory of Newspapers Collections on IFLANET – USA entries. Suzanne Kellerman will discuss the updating of the USA entries with Pär Nilsson

10. Any other Business

- 10.1 International Press Telecommunications Council. The pre-conference at Stockholm had shown clearly that there would be advantages to IFLA in joining a mature organisation, which had already established standards for press publishers internationally. It would be particularly relevant to engage in discussion with a representative body, regarding digitization of older newspapers, which may be in copyright, and also regarding the ingest of current newspapers into library digital storage systems. There was discussion regarding proposing that IFLA become a member of the IPTC. A motion "The IFLA Newspapers Section proposes to IFLA HQ, that IFLA becomes a member of IPTC". Proposed by Ed King and Seconded by Majlis Bremer-Laamanen. It was agreed that this matter would be taken further by the new Section Officers. Action: Frederick Zarndt; Pär Nilsson.
- **10.2** Further contact with the **World Association of Newspapers**: the paper given by Stig Norquist at Stockholm pre-conference had been useful. It was agreed that the contact should be taken further, particularly with regard to discussion over copyright. **Action: Pär Nilsson.**
- 10.3 Hartmut Walravens requested that all papers form the Russian Book Chamber conference, April 2009, be sent to him, so that these may be edited for publication.

- **10.3 Spring meeting/ conference 2011**. The possibility is to have a meeting in the USA, for the days 8-13 August, 2011. This would be as a joint meeting with the USA NDNP members, and as a pre-conference to the Puerto Rico IFLA conference of 13-18 August 2011. Precise dates and venue to be taken forward by the Chairman and Secretary. **Action: Frederick Zarndt; Pär Nilsson.**
- 10.4 Puerto Rico Open session. Options to be considered further. Action: Frederick Zarndt; Pär Nilsson.
- **10.5** Christoph Albers proposed that the Section establish **an open access newsletter**, possibly using the IFLA website. The remit of the journal might wider than that of the existing newsletter. It was agreed that Christoph Albers would create a proposal for the Standing Committee by the end of September 2009. **Action: Christoph Albers**.
- **10.6** The outgoing Chairman, Hartmut Walravens, thanked Ed King for all his work as Secretary of the Round Table and the Newspapers Section for the last ten years.
