6. IFLA Newspapers Section Conference Programmes 2011 - 2012

- 6.1 Theme and location for **2011 Newspapers Section Winter / Spring Meeting and Conference** Possible location sites suggested were Portugal, Africa, Japan, Brazil, Southeast Asia Malaysia. Action: Frederick Zarndt to follow up on Portugal and Malaysia sites. [Update: Email dated March 10, 2010 from Frederick Zarndt reported that the National Library of Malaysia agreed to host the 2011 Spring Conference]. Suggested themes for the conference included newspaper libraries past, present and future; models, standards and tools; the future of newspaper librarianship.
- 2011 IFLA Congress Puerto Rico. **Action:** The theme for the Newspapers Section Open Programme Session has yet to be developed.
- 6.2 Theme for **2012 IFLA General Conference Newspapers Section meeting** Christine Baryla suggested Paris as a possible location for the 2012 IFLA Satellite meeting prior to IFLA Congress in Helsinki, Finland. IFLA-PAC and Newspapers could co-sponsor the conference.

7. Newspapers Section Standing Committee membership

- 7.2 Financial Report There was no change in the Section's finances since the last report. The Section currently has 300 EUROs in its account. Hartmut Walravens requested using some of the funds to pay for publishing the proceedings from Stockholm and New Delhi conferences. Dr. Ramesh C. Gaur reported that there will 40 papers in the New Delhi conference proceedings. **Action:** Frederick Zarndt to forward Dr. Ramesh C. Gaur's contact information to Hartmut Walravens.

- 8. Next Newspapers Section Conference Several themes and location were offered for consideration. Georgia Higley offered the idea to hold the conference in Washington, D.C. preceding or following the National Digital Newspaper Program Awardee's meeting to ensure a large number of attendees. It was noted that the Library of Congress would serve as a good venue for the conference. Possible themes for the conference were web archiving, digitization, or citizen journalism. R. Venkata Kesavan suggested the theme newspapers past, present and future library services, user's needs and expectations, new developments, journalism, training personnel and training for digitization. Christine Baryla mentioned that IFLA-PAC may be interested in participating in this conference too. Sponsors will also need to be identified. Action: Georgia Higley and Suzanne Kellerman agreed to investigate venues, logistics and associated costs for a conference in the Washington D.C. area. Action: Frederick Zarndt offered to solicit sponsors.

9. Newspapers Section membership

Five additional members are needed to join the Section. The University of Kentucky (U.S.A) will join as an institutional member. Mary Molinaro, Director of Preservation and Digital Programs Department, University of Kentucky (U.S.A.) will apply to join the Section's Standing Committee. Anita Pujari and Dharam Vir agreed to join the Section. **Action:** Frederick Zarndt will send out the IFLA website URL and the Section's website information to Anita Pujari and Dharam Vir.
