### **6. Matters arising from the Minutes of the Wroclaw meeting and Action list 2017<sup>2</sup>, updated August 2018**

#### **6.1. Status and future of Study Group**

In 2017 in Wroclaw, a proposal was made to change the scope of the group so as to encompass all bibliographic standards, and not only the ISBD, as other IFLA bibliographic standards might need some support in their diffusion in linked data. As a consequence, it was proposed that the group change its name for “Bibliographic standards in linked data study group”.

After the conference, some concerns were expressed by email about this change of scope and name, so that the process has been stopped. The group addressed the concerns that were expressed, and eventually agreed with the general idea, but with amendments to ensure equal representation of all IFLA bibliographic standards, namely the ISBD RG, the BCM RG, and the Permanent Unimarc Committee. The group should have its own terms of reference that explicitly state how many members from each Review Group are needed.

The proposal is accepted. Mélanie Roche will draft the terms of reference for the group, and submit them to the Committee on Standards once the Study Group approves them.
