"The Outsider as Insider: Speaking Earnestly about the Rushdie Case -- ../papers/guest/ruth.htm -- "

The traditional IFLA/FAIFE guest lecture was given by Professor of Journalism, Mr. Arne Ruth, Stockholm, Sweden. Mr. Ruth is a journalist and visiting professor at Stockholm's University, Sweden. He was previously the editor in chief of the leading Swedish daily Dagens Nyheter and chair of the Swedish Rushdie Committee. He has published works on European culture and politics and is an internationally well-known advocate for freedom of expression. The lecture attracted an audience of around 150 persons and was followed by a lively discussion and questions from the floor.

"Libraries and Codes of Ethics"

The workshop included a presentation by Professor Thomas J. Froehlich of the School of Library and Information Science at Kent State University, Ohio, USA. His primary research focus has been ethical issues in the information professions. Mr Froehlich addressed the theories around professional ethical codes, their basis of values and their principals of intentions. Ms. Maria Antonieta Lopes Vigário, Portugal spoke of the process of adopting and the implementing of the Code of Ethics for Information Professionals in Portugal -- [../ethics/badcode.htm](#) -- . Following her introduction the 30 participants discussed fictive cases illustrating the ethical dilemmas faced by librarians in their everyday work.
