Resolutions:

- 1. The Governing Board resolved not to suspend cooperation with institutions and organisations representing the Russian Federation.
- 2. That IFLA issue a second statement restating its commitment to core values, preservation of cultural heritage and freedom of expression while deploring the destruction caused by the Russian military invasion.
- 3. That this position be published on the IFLA communication channels and communicated to all who have written to the Governing Board.
- 4. That the Governing Board endorses the work of IFLA's staff and volunteers in a Task Force to support the protection of cultural heritage in Ukraine.

- 5. That a summary of IFLA's actions to date with international organisations on the protection of cultural heritage in Ukraine be published widely and communicated to those who have written to the Governing Board.
- 6. That regular updates on the activities of the Task Force be published as part of IFLA's communications.
- 8. The Governing Board resolved that the application of the Russian Library Association to participate as an exhibitor at WLIC in 2022 be rejected due to safety and security concerns.
